We hereby consent that a copy of this assignment shall be deemed a full legal and formal equivalent of any document which may be required in any country in proof of the right of Radio Frequency Systems GmbH to apply for patent or other form of protection for said inventions and to claim the aforesaid benefit of the right of priority.


