



THIS AGREEMENT is made the _____ day of 2013

BETWEEN:-

- (1) **B.C.B. INTERNATIONAL LIMITED** a company registered in England and Wales under company registration number 01442485 whose registered office is at Units 7 & 8 Clydesmuir Road Industrial Estate, Tremorfa, Cardiff CF24 2QS, United Kingdom ("**BCB**"); and
- (2) **MATTHEW JOHN SEARLE** whose address in the United Kingdom is 74 High Street, Bruton, Somerset BA10 0AJ, and whose address in the United States of America is 307 5th Ave S, Safety Harbor Florida FL 34695 ("**Mr Searle**").

BACKGROUND

- (A) BCB wishes to receive the Business Services (as defined below) and Mr Searle has the skills, qualification and expertise to provide such Services.
- (B) BCB is willing to appoint Mr. Searle to provide the Business Services and Mr. Searle is willing to accept such appointment, all in accordance with the terms and conditions contained within this Agreement.

AGREEMENT

1. Definitions and Interpretations

In this Agreement and the Schedule:-

1.1. The following terms shall have the following meanings:-

"Business Services"

means the services to be provided by Mr. Searle in accordance with this Agreement as described in Schedule 1, and such other advisory and consultancy services as BCB may direct Mr. Searle to provide from time to time by notifying Mr. Searle

in writing;

"Commencement Date" means the date of this Agreement;

"Intellectual Property" means the patents, trade marks, service marks, rights (registered or unregistered) in any designs, applications for any of the foregoing, trade or business names, copyright (including rights in computer software) and topography rights, know how, secrets, formulae and processes, list of suppliers and customers and other proprietary knowledge and information, internet domain names, rights and forms of protection of a similar nature to any of the foregoing or having equivalent effect anywhere in the world and all rights under licences and consents in respect of any of the foregoing;

8. Intellectual Property and Materials

8.1. All Intellectual Property and Materials which have been prepared, conceived or developed by Mr. Searle for BCB prior to the date of this Agreement or which are prepared, conceived or developed by Mr Searle in the course of providing the Business Services pursuant to this Agreement, whether or not used by the Subsidiary or BCB, shall be the sole and exclusive property of BCB.

8.2. At BCB's written request, Mr Searle shall promptly deliver to BCB all Materials related to the Intellectual Property, including any Materials provided to Mr Searle by either the Subsidiary or BCB.

8.3. Mr Searle:-

8.3.1. shall disclose to BCB all Intellectual Property which has been prepared, conceived or developed by him for BCB prior to the date of this Agreement or which is prepared, conceived or developed by him pursuant to this Agreement;

8.3.2. hereby assigns all his rights, title and interest, in and to such Intellectual Property and the Materials to BCB, and, so far as it is legally possible, waives all his rights in relation to such Intellectual Property and Materials;

8.3.3. shall, at BCB's written request, do all things and execute all documents reasonably required by BCB to vest in BCB the right, title and interest referred to in clause 8.3.2;

- 8.3.4. shall, at BCB's written request, provide all reasonable assistance to BCB in connection with any filing made by BCB pursuant to clause 8.3.3, including executing such documents as BCB may reasonably require; and
 - 8.3.5. appoints BCB as his attorney to perform such acts and execute such documents as Mr Searle may be obliged to perform or execute pursuant to this clause 8 or otherwise in accordance with this Agreement.
- 8.4. This clause 8 shall survive the termination of this Agreement.




