CONFIRMATORY DESIGN ASSIGNMENT

Date: 8-NOV-2016

Parties:

1 'The Assignor' Eltav Wireless Monitoring Ltd. of 15 Hatassia St., Ranana 43654, Israel

2 'The Assignee' Rotork Controls Limited of Rotork House, Brassmill Lane, Lower Weston, Bath, BA1 3JQ, United Kingdom

Recitals:

- (A) The Assignor is the registered proprietor and beneficial owner of the registered designs listed in Schedule [1] hereto (hereinafter called 'the Designs') all of which stand in the name of the Assignor.
- (B) The Assignor and the Assignee entered into an agreement dated 30 November 2015 (hereinafter called 'the Agreement') for the transfer from the Assignor to the Assignee of certain intellectual property rights including the Designs.

Operative provisions:

For the good and valuable consideration set forth in the Agreement:

- 1. The Assignor hereby ASSIGNS absolutely to the Assignees free from incumbrances:
 - 1.1 all its right title and interest in and to the Designs to the intent that the Designs shall be in the name of and vest in the Assignee; together with all rights and powers arising or accrued from the same including the right to sue for damages and other remedies in respect of any infringement of such rights whether committed before or after the date of this Agreement.
- 2. The Assignor further covenants as follows:-
 - 2.1 that the Assignor is the sole proprietor of the Designs and has full power to enter into this Assignment;
 - 2.2 that the Assignor has given no licences or permissions to any third party to use any of the Designs nor suffered the Designs to be the subject of any charge or other encumbrance;
 - 2.3 that the Assignor has not made any other assignment or purported assignment of the Designs;

2.4 that at the request and cost of the Assignee it will at all times after the date of this Assignment do all such acts and execute all such documents as may reasonably be necessary or desirable both to secure the vesting in the Assignee of all rights assigned to the Assignee hereunder and to assist in the resolution of any question concerning the Designs.
