Dear Mr. McCammack,

Sure Hang has engaged Alfred Manufacturing (AMC) in the development and future manufacture of laser leveling devices. This development is presently in the prototype stage and moving rapidly toward manufacturing and the procurement of tools for manufacturing the first of a family of laser levels.

Presently, Sure Hang has outstanding/unpaid invoices from AMC, for services rendered, for the amount of \$61,650. Sure Hang needs the functioning prototype of the first laser level for marketing purposes. AMC requires immediate payment in full on the outstanding invoices, prior to releasing the prototype.

Sure Hang is requesting that the working laser level prototype be provided immediately in return for Sure Hang entering into a long-term, exclusive manufacturing agreement with AMC for the family of laser levelling devices for a period of 3 years.

Additionally,

Sure Hang will:

1-pay the outstanding invoices in full, as soon as funds are received from closing of a new financing arrangement on 07 August. Amount \$61,650.

2-pay for the initial production tooling, as soon as funds are received from closing of the aforementioned new financing arrangement. Estimated amount \$200,000, plus shipping.

3-pay a retainer of \$25,000 for continuing engineering services through delivery of first 10,000 production units.

AMC will:

1-assure market competitive pricing for the period of exclusivity for the family of Surehang laser level products.

Sure Hang and AMC will immediately negotiate and execute a formal long-term agreement (LTA) for the manufacture of the Sure Hang family of laser levelling devices. This LTA will include language to address change of control from Surehang/Jayson Hill to another independent ownership group. It is expected that this LTA will be fully executed by 21 August 2015.


