INTELLECTUAL PROPERTY ASSIGNMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT is made this 31st day of January, 2017, between BCKK HOLDING COMPANY, a Texas corporation, having a place of business at 2500 N. Big Spring Street, Suite 230, Midland, Texas 79705 ("Grantor"), and IBERIABANK, having a place of business at 11 East Greenway Plaza, Suite 2900, Houston, Texas 77046, a Louisiana state-chartered bank, as agent for Lenders (hereinafter defined) ("Agent").

WHEREAS, Grantor owns the Patents and Patent Applications (collectively, the "Patents") listed on Schedule A attached hereto, as the same may be amended from time to time;

WHEREAS, BCKK, INC., a Delaware corporation, the financial institutions described therein as lenders (collectively, "Lenders"), and Agent have entered into that certain Credit Agreement dated as of January 31, 2017 (as the same may hereafter be amended, restated, modified or supplemented from time to time, the "Credit Agreement");

WHEREAS, pursuant to the terms of the Security Agreement dated as of January 31, 2017, between Grantor and Agent, as agent for Lenders (the "Security Agreement"), Grantor has granted to Agent a security interest in all of its patents, trademarks and copyrights owned or at any time hereafter acquired by Grantor or in which Grantor now has or at any time in the future may acquire any right, title, or interest in or to, as collateral to secure the Obligations (as defined in the Security Agreement);

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereby agree as follows:

1. Grantor does hereby grant to Agent a security interest in the following property, wherever arising or located (the "IP Collateral"): all of Grantor's right, title and interest in and to the Patents now owned or at any time hereafter acquired by Grantor or in which Grantor now has or at any time in the future may acquire any right, title, interest or license to, including all proceeds and products of any and all of the foregoing.
2. Grantor does hereby further acknowledge and affirm that the rights and remedies of Agent with respect to its security interests in the IP Collateral made and granted herein are more fully set forth in the Credit Agreement and the Security Agreement, the terms and provisions of which are incorporated by reference herein, and include, without limitation, all rights and remedies of a secured party under the Uniform Commercial Code as adopted by the State of Texas as in effect from time to time.

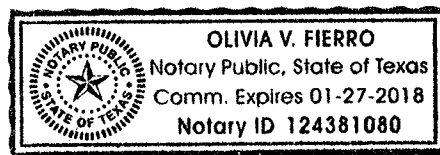
