

invention to Battelle Memorial Institute.

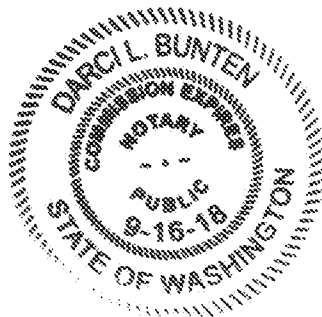
