
### ASSIGNMENT OF PATENT APPLICATION

ASSIGNOR hereby authorizes and requests the Director of the United States Patent and Trademark Office to issue all letters patents on said invention to ASSIGNEE. ASSIGNOR agrees to execute all instruments and documents required for the making and prosecution of applications for United States and foreign letters patents on said invention, for litigation regarding said letters patents, or for the purpose of protecting title to said invention or letters patents therefor.
