No. 29/560,537 and any divisions, extensions, renewals, re-examinations, continuations, continuations-in-part and any Letters Patent that issue therefrom;


2. We hereby authorize the Assignee to apply for Letters Patents in the United States in our name or in the name of the Assignee as the Assignee deems advisable;




