FIRST LIEN PATENT SECURITY AGREEMENT RELEASE

This FIRST LIEN PATENT SECURITY AGREEMENT RELEASE (this “*Release*”) dated February 17, 2017, is made by Jefferies Finance LLC, as collateral agent (in such capacity, the “*Collateral Agent*”) for the Secured Parties in favor of Vitera Healthcare Solutions, LLC, Lighting Acquisition LLC, Red Mountain Holdco, Inc., Successes, Inc., EHS Holdings, Inc., Integrated Physician Systems, L.L.C. and Crestview Acquisition Corp. (the “*Pre-Merger Grantors*”), and Greenway Medical Technologies, Inc., Greenway Registry, LLC and Greenway, LLC (the “*Post-Merger Grantors*”) (the Pre-Merger Grantors and the Post-Merger Grantors, collectively, the “*Grantors*”). All capitalized terms used herein and not otherwise defined shall have the meaning assigned to such terms in the Security Agreement (as defined below).

WHEREAS, the Grantors, the Collateral Agent, and certain other parties entered into that certain First Lien Credit Agreement, dated November 4, 2013 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “*Credit Agreement*”);

WHEREAS, the Grantors executed and delivered to the Collateral Agent that certain First Lien Security Agreement, dated November 4, 2013 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “*Security Agreement*”);

WHEREAS, under the terms of the Security Agreement, the Grantors granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a lien on and security interest in and to certain intellectual property, and have executed and delivered in favor of the Collateral Agent (i) that certain First Lien Patent Security Agreement, dated November 4, 2013 between the Collateral Agent and the Pre-Merger Grantors, (ii) that certain First Lien Patent Security Agreement, dated March 20, 2014 between the Collateral Agent and the Pre-Merger Grantors ((i) and (ii), collectively and as amended, amended and restated, supplemented or otherwise modified from time to time, the “*Pre-Merger Patent Security Agreements*”) and (iii) that certain First Lien Patent Security Agreement, dated November 4, 2013 between the Collateral Agent and the Post-Merger Grantors (as amended, amended and restated, supplemented or otherwise modified from time to time, the “*Post-Merger Patent Security Agreement*”);

WHEREAS, the Pre-Merger Patent Security Agreements were recorded with the United States Patent and Trademark Office on November 14, 2013 at Reel/Frame 031644/0403, and on March 20, 2014 at Reel/Frame 032488/0875, and the Post-Merger Patent Security Agreement was recorded with the United States Patent and Trademark Office on November 14, 2013 at Reel/Frame 031644/0365;

WHEREAS, the Grantors have requested and the Collateral Agent has agreed to release its Lien on and security interest in and to the Patent Collateral (as defined in the Pre-Merger Patent Security Agreements and the Post-Merger Patent Security Agreement) granted pursuant to the Pre-Merger Patent Security Agreements and the Post-Merger Patent Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

SECTION 1. Release of Grant of Security. The Collateral Agent, without recourse, representation, warranty or other assurance of any kind, hereby terminates, cancels and releases to the Grantors its Lien on and security interest in all of its right, title and interest in and to the Patent Collateral, including the patents and patent applications set forth on Schedule A, granted pursuant to the Pre-Merger Patent Security Agreements and the Post-Merger Patent Security Agreement.


SECTION 2. Recordation. The Collateral Agent authorizes and requests that the Commissioner for Patents at the United States Patent and Trademark Office and any other applicable government officer record this Release.

SECTION 3. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
