ASSIGNMENT

AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and I have not executed, and will not execute, any agreement in conflict herewith;

AND I HEREBY further covenant and agree that I will communicate to Assignee all facts known to me respecting said improvements, and testify in all legal proceeding, sign all lawful papers, execute all provisional, non-provisional, divisional, continuation, continuation-in-part, substitute, reissue, PCT, foreign, and all other applications, make all rightful oaths and generally do everything possible to aid Assignee to obtain and enforce proper patent protection for said improvements in all countries.

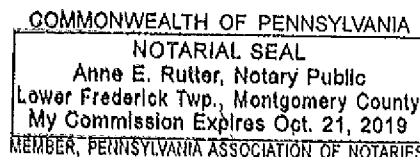
