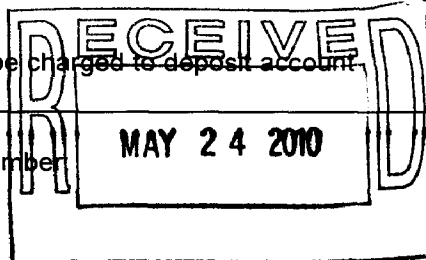

ASSIGNMENT

This Agreement is by and between J. Scott Bechtel and AvenCAP International LLC, an Indiana limited liability company (Applicant), and Pen-One Inc., a Michigan corporation having an office in Southfield, Michigan (PEN-ONE).

At the request and expense of PEN-ONE, Applicant shall assist PEN-ONE to make and prosecute applications, domestic and foreign, for patents and copyrights, reissues, continuations and extensions thereof, and in any controversy or legal proceedings relating to the INVENTIONS.

AND, Applicant hereby authorizes and requests the Commissioner of Patents in each respective country to issue the Letters Patent to PEN-ONE in accordance with this Agreement.
