DECLARATION OF THOMAS G. STEPHENS

“My name is Thomas G. Stephens. I am over eighteen (18) years of age, am of a sound mind, have not been convicted of a felony and have personal knowledge of the facts contained herein.


“I am the sole inventor of United States Letters Patent No. 9,437,993, issued on September 6, 2016, having Application Serial No. 14/991,714, and entitled “Device for Imparting Electrical Energy to One or More Plugs” (hereinafter the “patent”).

“On April 21, 2016, I assigned fifty percent (50%) of the right, title and interest in and to the patent to John P. Methner, which was memorialized in writing (hereinafter the “assignment”). Therefore, currently, I own fifty percent (50%) of the patent and John P. Methner owns fifty percent (50%) of the patent. On April 26, 2016, the assignment was recorded in the United States Patent & Trademark Office at reel 038385 and at frame 0894.

“On November 1, 2016, at reel 040185 and at frame 0208, a purported assignment of the right, title and interest of the patent between Design2 Corporation and I was recorded in the United States Patent & Trademark Office (hereinafter the “purported assignment”). The purported assignment is a fraud. I did not assign any right, title and interest to Design2 Corporation. Full ownership of the patent remains with John P. Methner and I as set forth above.

“I declare under penalty of perjury under the laws of the United States of America that the foregoing is true and correct.
