thereof, and any and all Letters Patent in each case, to the extent arising from the Applications and inventions described therein, and (iv) subject to the Settlement and License Agreement, the right to bring an action at law or in equity for infringement of any of the foregoing arising or accruing prior to this Assignment. The Applications and assigned rights shall be held and enjoyed by Remedi for its own use and enjoyment and the use and enjoyment of its successors, assigns or other legal representatives, to the end of the term or terms for which said patents are granted, will be granted, reissued, or extended as fully and entirely as the same would have been held and enjoyed by ATS if this assignment had not been made, as assignee of the entire right, title and interest therein and in and to all income, royalties, damages and payments now or hereafter due and/or payable with respect thereto (including without limitation, any payments for past, present and future infringements and misappropriations thereof), in and to all causes of action (either in law or in equity) and the right to sue, counterclaim, and recover for past, present and future infringements of the rights assigned or to be assigned under this Assignment, all of which being subject to the Settlement and License Agreement.

ATS agrees to execute and deliver to Remedi such further instruments and documents and to take such further actions as Remedi may reasonably request from time to time to effectuate and record the above assignments with all applicable government agencies and registries. This Assignment shall be governed by the laws of the State of Delaware and of the United States.

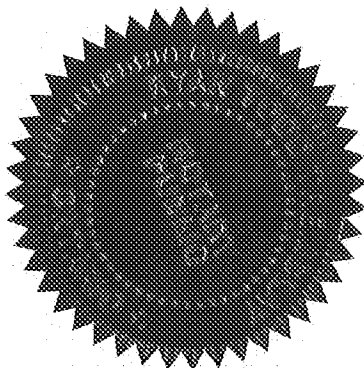
