ASSIGNMENT OF INVENTION AND PATENT RIGHTS





In any such action, suit, or proceeding, Assignor will be represented by the same legal counsel as Assignee at Assignee's expense.
5. Assignor grants to Assignee the power to insert on this Assignment any further identification, which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.
6. This agreement is binding upon and inures to the benefit of the successors, and assigns of the parties.
