AND we hereby further covenant and agree that we will communicate to said **ASS ARMOR, LLC**, its successors, legal representatives, and assigns, any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute any divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said **ASS ARMOR, LLC**, its successors, legal representatives, and assigns, to obtain and enforce proper patent protection, or an equivalent, for said improvements in all countries.




