

NOTICE OF SUCCESSION OF AGENCY

This NOTICE OF SUCCESSION OF AGENCY (this "Notice"), dated as of February 3, 2017 (the "Effective Date"), is executed by Deutsche Bank AG New York Branch, in its capacity as Administrative Agent and Collateral Agent under the Original Agreements (as defined below) (the "Prior Agent"), and JPMorgan Chase Bank, N.A., in its capacity as Administrative Agent and Collateral Agent under the Current Agreements (as defined below) (the "Successor Agent").

WHEREAS, pursuant to that certain Credit Agreement, dated as of May 25, 2011, by and among Envision Healthcare Corporation (f/k/a Emergency Medical Services Corporation), a Delaware corporation (as successor by merger to CDRT Merger Sub, Inc.) (the "Borrower"), the Prior Agent and certain other parties thereto (the "Original Credit Agreement"), the Prior Agent and certain grantor parties identified on the signature page thereto (the "Grantors") entered into that certain Guarantee and Collateral Agreement, dated as of May 25, 2011 (the "Original Guarantee and Collateral Agreement" and, together with the Original Credit Agreement, the "Original Agreements"), pursuant to which the Grantors granted a security interest in and to certain collateral;

WHEREAS, the Term Loan Notice and Confirmation of Grant of Security Interest in Patents, dated as of May 25, 2011, by and between the Prior Agent and American Medical Response, Inc., was recorded with the United States Patent and Trademark Office on June 3, 2011 at Reel/Frame 026390/0417, and the Term Loan Notice and Confirmation of Grant of Security Interest in Patents, dated as of December 24, 2013, by and between the Prior Agent and Rose Radiology, LLC, was recorded with the United States Patent and Trademark Office on December 24, 2013 at Reel/Frame 031869/0320, and the Term Loan Notice and Confirmation of Grant of Security Interest in Patents, dated as of September 10, 2014, by and between the Prior Agent and STREAMLINED MEDICAL SOLUTIONS LLC, was recorded with the United States Patent and Trademark Office on April 2, 2015 at Reel/Frame 035365/0117, with respect to the patents identified on Schedule A attached hereto;

WHEREAS, the Original Credit Agreement was amended and restated, and the Original Guarantee and Collateral Agreement was amended, as of December 1, 2016 (as amended and restated, collectively, the "Current Agreements"), and in connection with the transactions under the Current Agreements, the Prior Agent, the Successor Agent, the Borrower and certain other parties have entered into that certain Agency Transfer Agreement, dated as of December 1, 2016, whereby the Prior Agent resigned as Administrative Agent and Collateral Agent and was succeeded to and replaced by the Successor Agent as successor Administrative Agent and Collateral Agent;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

- 1. <u>Defined Terms</u>. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Agency Transfer Agreement.
- 2. Succession and Replacement of Agency. Pursuant to the terms and conditions set forth in the Agency Transfer Agreement, the Prior Agent has ceased to be Administrative Agent and Collateral Agent and is succeeded to and replaced by the Successor Agent as Administrative Agent and Collateral Agent. Nothing herein shall be deemed to terminate, interrupt or impair the continuity of the security interest in the collateral originally granted to the Prior Agent under the Original Guarantee and Collateral Agreement, which security interest is now succeeded by and transferred to the Successor Agent.
