## **RELEASE OF PATENT SECURITY AGREEMENT**

WHEREAS, pursuant to that certain NOTICE OF GRANT OF A SECURITY INTEREST IN PATENTS, dated as of July 29, 2013 (the "Patent Security Agreement"), recorded in the United States Patent and Trademark Office at Reel 030937, Frame 0547, Highwinds Holdings, Inc. (the "Releasee"), granted to Cerberus Business Finance, LLC, as the collateral agent for itself and certain lenders (in such capacity, together with its successors and assigns, if any, the "Releasor"), for the benefit of the Secured Parties, a continuing security interest in all right, title and interest of Releasee in, to and under the letter patents, design patents and utility patents listed on the attached Schedule A, which patents are issued or applied for in the United States Patent and Trademark Office (the "Patents"), and the applications and registrations thereof, and all proceeds thereof, including without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (collectively, the "Collateral") to secure the payment, performance and observance of the Secured Obligations; and

WHEREAS, Releasees have requested and Releasor has agreed to provide this Release of Patent Security Agreement to confirm the release, relinquishment and discharge of its continuing security interest in the Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Patent Security Agreement.
2. Release of Security Interest. Releasor hereby releases to Releasees, and releases to the Releasees on behalf of the Secured Parties, its continuing security interest in the Collateral.
