ASSIGNMENT AGREEMENT

This Assignment Agreement (this "Agreement") is made as of March 20, 2017 (the "Effective Date"), by and between Patrick T. Matthews of Minnesota ("Assignor") and Sign Zone, Inc. of Ramsey, Minnesota ("Assignee"). (Collectively, hereinafter referred to as "Parties").

RECITALS

WHEREAS, Assignor is owner of the rights, title and interest, including, without limitation, the intellectual property rights, in and to such intellectual property contained in said U.S. Patent;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

AGREEMENT

1. DEFINITIONS

For the purposes of this Agreement, the following terms will have the meanings ascribed to them as follows:

1.1 "Assigned Property" means the invention described in the U.S. Patent.

1.2 "U.S. Patent" means the intellectual property titled "Tent Foot Device".

ASSIGNMENT

Assignor hereby irrevocably assigns, conveys, sells, grants and transfers and agrees to assign, convey, sell, grant and transfer to Assignee the following rights (collectively, the "Rights"):

Intellectual Property described in the U.S. Patent. Subject to the terms and conditions of this Agreement, Assignor hereby irrevocably assigns, conveys, sells, grants and transfers and agrees to assign, convey, sell, grant and transfer to Assignee, its successors and assigns all of its rights, title and interest of every kind and character throughout the world, including moral rights, in and to the Intellectual Property to the full extent of its ownership or interest therein.

3. GENERAL




