And, I hereby agree to communicate to the Assignee or its representatives any facts known to me respecting said Invention, improvements, Copyrights and Trademarks, to testify in any legal proceeding relating thereto, sign all lawful papers, execute all applications and documentation, including, without limitation, divisionals, continuations and reissue applications, and make all rightful oaths and execute any and all documents that may be required in order for Assignee to register, protect, and/or cover all intellectual property rights in and to said Invention, Trademarks and Copyrights in any countries and in its own name.
