ASSIGNMENT

The Commissioner of Patents is hereby authorized and requested to issue the Letters Patent solely in accordance with the terms of this Assignment to ViroCyt, LLC its successors, legal representatives and assigns, as the assignee of the entire right, title and interest therein.
