


DECLARATION TO CORRECT ASSIGNMENT

I, Nicholas G. Doinoff, hereby state and declare:

1. I am the President of Biometric Equipment & Safety Technology Labs, Inc.
2. I have been President from at least October 2008 until present.
3. On November 7, 2009 an Assignment was recorded in the US Patent Office assigning all right, title and interest in US Patent Application Serial Number 12/595,007 from the inventors Pierre M. Crespo and Alex Chan to B.E.S.T. Labs, Inc.
4. US Patent Application Number 12/595,007 has issued as US Patent Number 7,823,681.
5. The recital of B.E.S.T. Labs, Inc., which is the abbreviation for Biometric Equipment & Safety Technology Labs, Inc., was in error, as the full legal name of the corporation, Biometric Equipment & Safety Technology Labs, Inc., should have been included rather than the abbreviation.
6. The improper listing of B.E.S.T. Lab, Inc. was not done with deceptive intent, as Biometric Equipment & Safety Technology Labs, Inc. was using B.E.S.T. Labs, Inc. on marketing material and the assignors believed that the company was legally doing business as B.E.S.T. Labs, Inc.
7. Although Biometric Equipment & Safety Technology Labs, Inc. used the abbreviation of B.E.S.T. Labs, Inc. in marketing material, B.E.S.T. Labs, Inc. was not a legally registered name for Biometric Equipment & Safety Technology Labs, Inc.
8. At least one of the assignors is not available to execute a corrective Assignment to correct the error and replace B.E.S.T. Labs, Inc. with its proper legal name of Biometric Equipment & Safety Technology Labs, Inc.

9. As an officer and legal representative of Biometric Equipment & Safety Technology Labs, Inc., I request that the erroneous abbreviated name of B.E.S.T. Labs, Inc. be replaced with the proper legal name of Biometric Equipment & Safety Technology Labs, Inc. on the assignment. A copy of the corrected Notice of Recordation of Assignment Document and the corrected Patent Assignment cover sheet are being filed herewith.
