ASSIGNOR HEREBY covenants that when requested, without charge to, but at the expense of, said ASSIGNEE, to carry out in good faith the intent and purpose of this Assignment; ASSIGNOR will disclose all known facts relating to said Invention and the history thereof; ASSIGNOR will testify in all legal proceedings, and do everything possible which ASSIGNEE shall consider desirable for aiding in securing, maintaining and enforcing proper patent and intellectual property protection for said Invention, including but not limited to executing all rightful oaths, assignments, powers of attorney and other papers, as shall be necessary, and ASSIGNOR hereby irrevocably appoints ASSIGNEE as ASSIGNOR'S attorney-in-fact with power to execute on ASSIGNOR'S behalf any and all documents necessary to carry out the terms of this Assignment. ASSIGNOR hereby covenants with said ASSIGNEE that ASSIGNOR has made to others no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed, and that ASSIGNOR has full right to convey the entire right, title and interest as herein expressed.
