Last Will and Testament

OF

JAMES S. COLLINS

I, JAMES S. COLLINS, of Center Township, Beaver County, Commonwealth of Pennsylvania, being of sound mind, memory and understanding, do hereby make, publish and declare this to be my Last Will and Testament, in manner and form following hereby revoking any Will or Wills heretofore made by me.

1. I direct that all my just debts and funeral expenses be paid and satisfied as soon as may be convenient after my decease.

2. I give, devise and bequeath all my estate, real, personal and mixed unto my beloved wife, SANDRA LEE COLLINS, and beloved children, JAMES, SCOTT, ROBERT, AND TAMMY, and their heirs to have and to hold forever, subject to provisions hereinafter set forth.

A. The house will become the total property of my wife, along with all other real and personal property.

B. Any bonds and/or stocks shall be divided $1/2$ to my wife and $1/8$ to each of the children.

C. My wife being the sole beneficiary of my insurance policies shall keep $1/2$ the total paid to her and distribute to the children the remaining, equally.

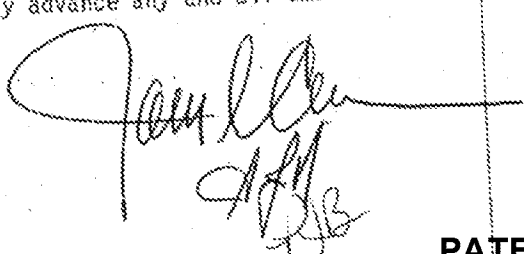
D. The legacy falling to my children as hereinabove named, under the provisions of this, my Last Will and Testament, shall be retained by my Trustee hereinafter named, IN TRUST, to invest and reinvest the same, to collect the income, and after paying all expenses incident to the management of the trust, to use and apply as much of the net income and principal as may be necessary in the sole discretion of my Trustee for my beloved children, for education, care, support and general welfare as may be necessary in receiving said education. It is my express order that "education" be construed to mean also a college education.

E. The trustee hereinafter named shall distribute the entire balance of said TRUST FUND, including principal, interest and accumulation of income to my beloved children, share and share alike, upon their reaching their twenty-first (21) birthday and not one day sooner unless and/or in the event any of my beloved children, above named, shall come into necessitous circumstances or be in the need of financial assistance, said Trustee, may advance any and all amounts of my entire estate to any of my beloved children.

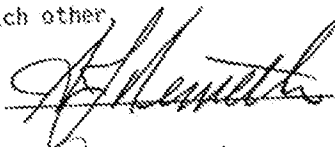
