FOURTH: The Certificate of Incorporation of Citicorp Credit Services, Inc. (USA) shall be the Certificate of Incorporation of the surviving entity.

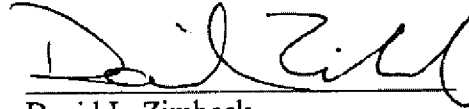
FIFTH: The Merger shall become effective on December 1, 2014 for accounting purposes only.
