Articles of Amendment of Alcoa Inc.

Article FIRST of the Amended and Restated Articles of Incorporation is amended so that, as amended, it shall read in its entirety:

“FIRST. The name of the corporation is Arconic Inc.”

Article FIFTH of the Amended and Restated Articles of Incorporation is amended by adding at the end thereof a new section “7” stating as follows:

“7. Uncertificated Shares. Shares of Common Stock, or any part thereof, to the extent determined by the Board of Directors, shall be uncertificated; provided that this section 7 shall not apply to shares represented by a certificate until the certificate is surrendered to the corporation.”
