PATENT AND TRADEMARK ASSIGNMENT

This Patent and Trademark Assignment ("**Assignment**") is made and effective as of December 13, 2012 by and between Groen Brothers Aviation, Inc., a Utah corporation ("**Parent**"), Groen Brothers Aviation USA, Inc., a Utah corporation ("**GBA USA**" and together with Parent, the "**Transferor**"), and Groen Brothers Aviation Global, Inc., a Delaware corporation ("**Transferee**").

WHEREAS, each of GBA USA, GBA LLC and Transferee is a wholly-owned subsidiary of Parent;

WHEREAS, a Contribution Agreement was entered into as of December 13, 2012 among Transferor and the Transferee (the "**Contribution Agreement**");

WHEREAS, pursuant to the Contribution Agreement, Transferor is contributing substantially all of its assets (other than certain Excluded Assets), including but not limited to, all intellectual property and intellectual property rights of Transferor, whether registered or unregistered, including but not limited to all (a) inventions (whether patentable or unpatentable and whether or not reduced to practice), improvements thereto, and patents, patent applications, patent disclosures, together with all reissues, continuations, continuations-in-part, divisions, extensions or reexaminations thereof, (b) trademarks, service marks, trade names, logos, brand names, trade dress, corporate names, and other source indicators, including all good will associated with any of the foregoing, and all applications, registrations, and renewals in connection therewith, (c) internet domain names, (d) copyrights (registered or unregistered), copyrightable works, website content, and all applications, registrations and renewals in connection therewith, (e) mask works and all applications, registrations, and renewals in connection therewith, (f) computer software (including source code and object code versions), data, databases, and all related documentation, (g) trade secrets and other confidential information, including ideas, formulas, recipes, compositions, know-how, manufacturing and production processes and techniques, methodologies, processes, advertising and marketing plans, research and development information, drawings, specifications, designs, business plans and proposals, technical data, financial and marketing plans, and customer and supplier lists and information (collectively, the "**Transferred Intellectual Property**") (all assets together with the Transferred Intellectual Property, the "**Contributed Assets**") to Transferee and Transferee is accepting the Contributed Assets.

NOW, THEREFORE, in consideration of the foregoing recitals, the mutual covenants set forth in this Assignment, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. **Defined Terms.** Unless specifically defined herein, all capitalized terms used in this Assignment shall have the meanings ascribed to such terms in the Contribution Agreement.
2. **Right to Transfer.** Transferor hereby represents and warrants that it has full right to contribute the Contributed Assets on the terms and subject to the conditions of this Assignment as of the date hereof.
3. **Assignment.** For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Transferor does hereby contribute, assign, transfer and convey to Transferee all of Transferor's worldwide right, title and interest, including all common law rights, any rights to income, any royalties, any licensing deriving from and in, to and under the assets set forth on Schedule A, together with any goodwill of the business associated therewith, together with all rights and privileges

granted and secured thereby, including the right to maintain and pursue enforceable rights in the Transferred Intellectual Property, and to file any and all subsequent applications based on the Transferred Intellectual Property including any and all conversions, divisions, continuations, continuations-in-part, substitutions, renewals, reexaminations, and reissues thereof together with the right of priority under the International Convention for the Protection of Industrial Property, Inter-American Convention relating to Patents, Designs and Industrial Models, and any other international agreements to which the United States of America adheres, and to sue and recover for any past violation, said rights to be held and enjoyed by Transferee, for its own use and benefit and for the use and benefit of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Transferor if this Assignment and contribution had not been made.

4. **Acceptance and Assumption.** Transferee hereby acquires the Contributed Assets from Transferor and accepts all right, title and interest in and to the Contributed Assets and assumes all of the rights, benefits, burdens, liabilities and obligations pertaining to the Contributed Assets and arising from and after the date hereof.

5. **Intellectual Property Authorization.** Transferor hereby authorizes and requests the officials at the Patent and Trademark Offices in the United States and its territorial possessions and in any and all foreign countries to issue any and all enforceable rights, including letters patent or registrations, when granted, to the Transferee for the sole use and benefit of the Transferee and of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Transferor if this assignment and contribution had not been made.

6. **Severability.** If any provision of this Assignment is held to be invalid or unenforceable in any respect under any applicable law, such invalidity or unenforceability will have no effect on the validity or enforceability of any other provision, but this Assignment shall be reformed, construed and enforced in such jurisdiction as if such invalid or unenforceable provision had never been contained herein, and each term and provision of this Assignment will be valid and enforced to the fullest extent that is otherwise enforceable under applicable law.

7. **Amendment and Waiver.** this Assignment may be amended or modified only by a written agreement executed by all parties hereto. Any right, power or privilege under this Assignment may be waived only in a writing executed by the party having such right, power or privilege. No other course of dealing between or among any of the parties or any delay in exercising any rights pursuant to this Assignment shall operate as a waiver of any rights of any party.

8. **No Strict Construction.** The parties acknowledge that this Assignment has been prepared jointly by the parties, and shall not be strictly construed against any party.

9. **Headings.** The headings used in this Assignment are for the purpose of reference only and shall not affect the meaning or interpretation of any provision of this Assignment.

10. **Governing Law; Consent to Jurisdiction; Venue; Waiver of Jury Trial.** THIS ASSIGNMENT WILL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE DOMESTIC LAWS OF THE STATE OF NEW YORK FOR CONTRACTS ENTERED INTO AND TO BE PERFORMED IN SUCH STATE WITHOUT GIVING EFFECT TO ANY CHOICE OR CONFLICT OF LAW PROVISION OR RULE (WHETHER OF THE STATE OF NEW YORK OR ANY OTHER JURISDICTION) THAT WOULD CAUSE THE APPLICATION OF THE LAWS OF ANY JURISDICTION OTHER THAN THE STATE OF NEW YORK. THE PARTIES HEREBY IRREVOCABLY SUBMIT TO THE EXCLUSIVE JURISDICTION OF THE COURTS IN THE STATE OF NEW YORK OVER ANY DISPUTE ARISING OUT OF OR RELATING TO THIS ASSIGNMENT OR ANY OF THE TRANSACTIONS CONTEMPLATED HEREBY AND EACH

PARTY HEREBY IRREVOCABLY CONSENTS TO THE JURISDICTION OF SUCH COURTS (AND OF THE APPROPRIATE APPELLATE COURTS) IN ANY ACTION OR PROCEEDING IN RESPECT OF SUCH DISPUTE. THE PARTIES HEREBY IRREVOCABLY WAIVE ANY OBJECTION OF VENUE LAID THEREIN. THE PARTIES AGREE TO ACCEPT SERVICE OF ANY SUMMONS, COMPLAINT OR OTHER INITIAL PLEADING MADE IN THE MANNER PROVIDED FOR THE GIVING OF NOTICES IN THIS ASSIGNMENT. NOTHING IN THIS SECTION 5(i) HOWEVER, SHALL AFFECT THE RIGHT OF ANY PARTY TO SERVE SUCH SUMMONS, COMPLAINT OR INITIAL PLEADING IN ANY OTHER MANNER PERMITTED BY LAW. EACH PARTY HERETO HEREBY IRREVOCABLY WAIVES ANY AND ALL RIGHT TO TRIAL BY JURY IN ANY LEGAL PROCEEDING ARISING OUT OF OR RELATING TO THIS ASSIGNMENT OR THE TRANSACTIONS CONTEMPLATED HEREBY.

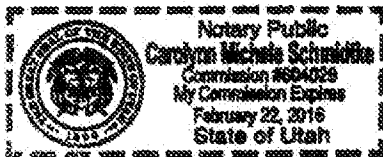
