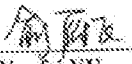
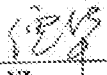
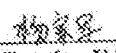
which claims priority to Chinese Application No. 201610178811.X, filed March 23, 2016, and for which I am about to file or have filed an application for Letters Patent of the United States;
