Extract of the minutes drawn up by the notary public Kim LAGAE, at Bruxelles, on 18 October 2016.

The Extraordinary General Meeting decided to replace the company name by OGEDA with effect on 18 October 2016 and to replace Article 1 of the status with the following text:

“The company has the form of a limited company.

It adopts the name “OGEDA”.

This name must always be preceded or followed immediately by the words “société anonyme” or the abbreviation “SA”.”
