TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (the “*Termination and Release*”) is granted as of April 4, 2017 by **SILICON VALLEY BANK**, as Administrative Agent for the Lenders (in such capacity, the “*Administrative Agent*”), in favor of **CARBONITE, INC.**, a Delaware corporation (the “*Grantor*”).

WHEREAS, Grantor executed and delivered an Intellectual Property Security Agreement (the “*Grant*”) dated as of May 6, 2015 granting Administrative Agent a security interest in certain Copyrights, Trademarks, and Patents (collectively, the “*Intellectual Property*”);

WHEREAS, the Grant was recorded with the Patent Division of the USPTO on May 6, 2015, at Reel 035602, Frame 0605;

WHEREAS, Grantor has requested that Administrative Agent hereby terminate, release and discharge fully its security interests in all right, title and interest of Grantor in, to and under Grantor’s Intellectual Property, including, without limitation, the Intellectual Property identified in **Exhibit A** hereto; and

WHEREAS, Grantor has requested that Administrative Agent provide a document suitable for recording in the USPTO to evidence the release of its security interests in the Grantor’s Intellectual Property as herein provided.

WHEREAS, capitalized terms used but not defined herein shall have the meaning set forth in the Grant.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby:

1. terminates the Grant and releases, terminates and discharges all liens and security interests in Grantor’s right, title and interest in, to and under the Intellectual Property, and all goodwill associated therewith, including those Intellectual Property identified in **EXHIBIT A**, hereto;
2. authorizes and requests that this Termination and Release be recorded at the USPTO; and
3. agrees that it shall, and at Grantor’s, reasonable request and Grantor’s expense, execute, acknowledge and deliver to Grantor all further releases and other documents, and take all other actions necessary or reasonably desirable for the release of such security interest.
