extensions, renewals, and reissues thereof, and we hereby authorize and request the Commissioner of Patents and Trademarks of the United States of America, and any Official of any country or countries foreign to the United States of America, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said Invention to said Hanchett Entry Systems, Inc., its successors, legal representatives, and assigns, in accordance with the terms of this instrument.

And, we hereby covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith.

And, we hereby further covenant and agree that we will communicate to said Hanchett Entry Systems, Inc., its successors, legal representatives, and assigns, any fact known to us respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all non-provisional, provisional, divisional, renewal, substitutional, continuation, and reissue applications, make all rightful declarations and/or oaths and generally do everything possible to aid said Hanchett Entry Systems, Inc., its successors, legal representatives, and assigns, to obtain and enforce proper patent protection for said invention in all countries.
