
## ASSIGNMENT

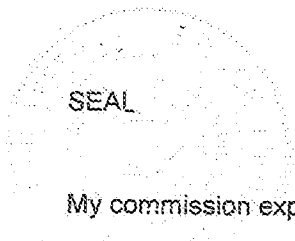


