**ASSIGNMENT**

WHEREAS, I, Stewart Swiss, a citizen of The United States of America, having an address of 180 Rodeo Drive, Brentwood, NY 11717, United States of America (hereinafter referred to as the "ASSIGNOR"), has invented, together with Greg Pardes (now deceased), a citizen of The United States of America, certain new and useful improvements in **ONE WAY VALVE ASSEMBLY**, for which U.S. Patent Application No. 13/293,990 was filed on November 10, 2011, and for which Letters Patent of the United States were issued on May 21, 2013, and were assigned U.S. Patent No. 8,444,027, and

WHEREAS, Reseal International Limited Partnership, having an address of 445 Park Avenue, Suite 900, New York, NY 10022, United States of America (hereinafter referred to as the "ASSIGNEE"), is desirous of obtaining the entire right, title and interest in, to and under the improvements and the application, and in U.S. Patent No. 8,444,027;


NOW, THEREFORE, in consideration of the sum of Five Dollars (\$5.00) and other good and valuable consideration paid by ASSIGNEE to ASSIGNOR, the receipt of which is hereby acknowledged, ASSIGNOR has sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over, unto ASSIGNEE, its successors, legal representatives and assigns, his entire right, title and interest in, to and under the improvements, and the application and all divisions, renewals, substitutes and continuations thereof, of whatever type, and all Letters Patent of the United States that have been or may be granted thereon and all reissues and extensions thereof, and all applications for Letters Patent and any legal equivalent thereof, including the right to claim priority, that have been or may hereafter be filed for the improvements in any region, country or countries foreign to the United States, and all Letters Patent and any legal equivalent thereof that have been or may be granted for the improvements in any region, country or countries foreign to the United States, and all extensions, renewals and reissues thereof, the same to be held and enjoyed by ASSIGNEE for its own use and benefit and for the use and benefit of its successors, assigns or other legal representatives fully and entirely as if the same would have been held and enjoyed by ASSIGNOR if this Assignment had not been made, to the end of the term or terms for which any Letters Patent and any legal equivalent thereof has been or may be granted;

AND ASSIGNOR HEREBY authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States whose duty it is to issue patents on applications as aforesaid, to record this Assignment, and to issue all Letters Patent for the improvements to ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument;

AND ASSIGNOR HEREBY covenants that ASSIGNOR has the full right to convey the entire interest herein assigned, and that ASSIGNOR has not executed, and will not execute, any agreement, assignment, sale or encumbrance in conflict herewith;

AND ASSIGNOR HEREBY further covenants and agrees that ASSIGNOR will communicate to ASSIGNEE, its successors, legal representatives and assigns, any facts known to the ASSIGNOR respecting the improvements, and will testify in any legal proceeding, sign all lawful papers, execute all international, regional, divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection that ASSIGNEE may deem useful, desired or necessary for the improvements in all countries.
