AND said ASSIGNOR hereby agrees to perform, upon the request of said CO-ASSIGNEE, or said CO-ASSIGNEE'S successors or assigns, any and all acts relating to maintaining and/or to the asserting of said patent, including any and all renewals, reissues and prolongations thereof.
