AMENDMENT TO CONTRACT RESEARCH AND DEVELOPMENT AGREEMENT

This Amendment to the Contract Research and Development Agreement effective as of 18 August 2011 ("Agreement") and entered into effective as the date of last signing is by and between:

DePuy (Ireland), an Irish corporation having its registered office at Loughbeg Industrial Estate, Ringaskiddy, Co Cork, Ireland, ("Principal")

AND

DePuy Synthes Products, Inc, a Delaware corporation having its registered office at 325 Paramount Drive, Raynham, MA 02767-0350, U.S.A. ("Contract Researcher")

(hereinafter individually referred to as a "Party"; collectively referred as the "Parties").

WHEREAS, DePuy Products, Inc. (an Affiliate of Contract Researcher) and Principal entered into a Contract Research and Development Agreement on August 11, 2011;

WHEREAS, DePuy Products, Inc. assigned the Agreement to the Contract Researcher in 2012.

WHEREAS, the Parties wish to add another project to the Research and Development Programme as set forth in Schedule 2; and

WHEREAS, the parties wish to update the Agreement to reflect these changes.

NOW, THEREFORE, in consideration of the covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree to amend the Agreement as follows:

1. The definition of the term "Intellectual Property Rights" in Section 1.1 of the Agreement shall be deleted and replaced with the following:

"Intellectual Property Rights" means inventions, improvements, Know-How, ideas, copyrightable works, records, reports, specifications, drawings and models made or conceived by the Contract Researcher (or its employees or outside developers under an obligation to assign such works to the Contract Researcher) in connection with the Research and Development Programme and includes but is not limited to copyrights, neighboring rights, rights on databases, patents, patent applications, trademarks, designs, processes, methods, models, trade secrets and Know-How, resulting from the Research and Development Programme and includes the patent and patent applications identified as "Current Research and Development Programme Patents and Patent Applications" in

Schedule 3, and all counterparts of those listed in Schedule 3 worldwide, as well as any and all related continuations, continuations-in-part, divisional, renewals, reissues, reexaminations, extensions, patents of addition, patents of importation and all patents and patent applications claiming priority to the patents and patent applications listed in Schedule 3.

2. The definition of the term "Research and Development Programme" in Section 1.1 of the Agreement shall be deleted and replaced with the following:

"Research and Development Programme" shall mean and all of the research and development programmes identified in Schedule 2 which have been and will be carried out by Contract Researcher and its Affiliates on behalf of Principal under the terms and conditions of this Agreement, or any other programme defined by the parties from time to time reflected in an updated Schedule 2.

- 3. Schedule 2 shall be deleted and replaced with the attached Schedule 2.
- 4. Schedule 3 shall be amended to include the cases highlighted in the attached Schedule 3a.


