DEED OF ASSIGNMENT

Date: 17TH MARCH, 2017

Parties:

- (1) Barry Peter Liversidge, a British Citizen of The Wick, Wick Road, Langham, Colchester, Essex, CO4 5PE, England, of the first part ("the Assignor").
- (2) tip-top.com Ltd, incorporated under the laws of England under company registration number 04495957, of 2 Moss Road, Stanway, Colchester, Essex, CO3 0LE, England of the second part ("the Assignee").

Recitals:

- (A) The Assignor is the proprietor of patent applications and granted patents (the "Patents") as listed in the Schedule in respect of inventions the subjects of which are specified in the Schedule ("the Inventions").
- (B) The Assignor has agreed ("the Agreement") to assign the Patents and the Inventions to the Assignee as set out below.

Operative provisions:

- 1 In pursuance of the Agreement and in consideration of the sum of £1 (one pound sterling), the receipt of which is hereby acknowledged, the Assignor with full title guarantee HEREBY ASSIGNS unto the Assignee:
 - 1.1 all of the Assignor's right and title to and interest in the Inventions and the full and exclusive benefit of the Inventions throughout the world;
 - 1.2 all of the rights of the Assignor to and in the Patents throughout the world; and
 - 1.3 all rights of action, powers and benefits arising from ownership of the Patents, including without limitation the right to sue for damages and other legal and equitable remedies (and retain any financial award made in any action) in respect of all causes of action arising prior to, on or after the date of this Assignment

TO HOLD the same unto the Assignee absolutely.

- 2 The Assignor HEREBY CONVENANTS with the Assignee that the Assignor will at the expense of the Assignee execute sign and do all such instruments applications documents acts and things as may reasonably be required by the Assignee to enable the Assignee or its nominee to enjoy the full benefit of the rights hereby assigned and to apply for and obtain registration of the Assignee as the registered proprietor of the Patents.
- 3 The amount stated in this Deed to be payable by the Assignee to the Assignor is exclusive of value added tax chargeable under or pursuant to the Value Added Tax Act 1994 and any other tax of a similar nature, whether imposed in a member state of the European Union or elsewhere ("VAT") which shall be payable by the Assignee and the Assignor shall deliver to the Assignee upon request a proper VAT invoice for the amount (if any) of VAT chargeable.
- 4 This Assignment shall be construed in accordance with and governed by English law and the English courts shall have jurisdiction over any disputes thereunder.

5 Unless expressly provided in this Agreement, no term of this Agreement is enforceable pursuant to the Contracts (Rights of Third Parties) Act 1999 by any person who is not a party to it.
