I agree for myself and for my heir or heirs, executor and administrator to communicate to said ASSIGNEE, its successors, assigns, nominees or other legal representatives, all facts known to me respecting said improvements, whenever requested, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute and reissue applications, make all rightful oaths and do all lawful acts requisite for the application, for such divisional, continuation, substitute and reissue applications or the procuring thereof, and I further covenant and agree that I will, at any time upon request, do everything legally possible to aid said ASSIGNEE, its successors, assigns, nominees or other legal representatives, either in its or their own name, to maintain and enforce any patent for said improvements without further consideration but at the expense of said ASSIGNEE, its successors, assigns, nominees or other legal representatives.

I hereby authorize and request the United States Commissioner of Patents to issue any and all Letters Patent which may be granted upon any of said applications, to ASSIGNEE as the assignee of the entire right, title and interest in and to the same, for its sole use and behoof; and for the use and behoof of its successors, assigns, nominees, or other legal representatives, to the full end of the term for which said Letters Patent may be granted.
