ASSIGNMENT AND AGREEMENT



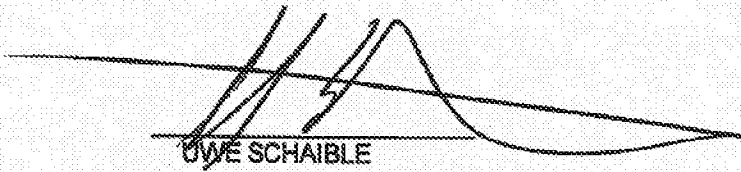


