ASSIGNMENT



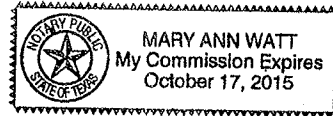

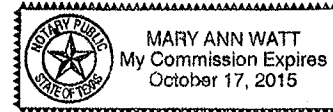
