**HEREBY AGREE** to execute, and assist with executing, any and all applications for Letters Patent, and to furnish all data and documents and to execute any papers which may be necessary or convenient for the preparation, filing, or prosecution of such applications, except it is understood that Contractor and/or I, **JOHN KEISLING**, shall not be subject to any out-of-pocket expense relative to such action.
