TERMINATION AND RELEASE OF PATENT SECURITY AGREEMENT

**THIS TERMINATION AND RELEASE OF PATENT SECURITY AGREEMENT** (this "Termination"), is dated as of April ~~16~~<sup>18</sup>, 2017, and made by **GENERAL ELECTRIC COMPANY**, as Administrative Agent (as successor in interest by merger to General Electric Capital Corporation, as Administrative Agent) ("Grantee") to **CHILDREN'S FACTORY, LLC**, a Delaware limited liability company ("Grantor").

**WHEREAS**, pursuant to that certain Patent Security Agreement dated as of May 18, 2016, made by Grantor in favor of Grantee (the "Security Agreement"), the Grantor granted to the Grantee, among other collateral as set forth therein, a security interest in all of the Grantor's right, title and interest in, to and under the United States patent registrations and applications listed on the attached Schedule A (the "Patents");

**WHEREAS**, the Security Agreement was recorded in the Patent Division of the United States Patent and Trademark Office on May 18, 2016, at Reel 038744 and Frame 0116; and

**WHEREAS**, Grantee now desires to terminate and release the Security Agreement;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged Grantee hereby states as follows:


1. **Definitions.** All terms not herein defined, have the meanings set forth in the Security Agreement referenced above.

2. **Release of Security Interest.** Grantee hereby terminates the Security Agreement and terminates, releases and discharges any security interest in and lien upon the Patents and other Patent Collateral, and reassigns, transfers, and conveys to the person or persons legally entitled thereto all right, title and interest of Grantee in the Patents and other Patent Collateral.
