**Amended and Restated CERTIFICATE OF ORGANIZATION  
of MachineGunArmory, LLC  
- Original File Date of: February 6, 2006 -**

We, the undersigned persons, do hereby adopt the following Certificate of Organization for the purpose of forming a Utah Limited Liability Company. The Amendment was adopted by the members and manager.

**Article I NAME**
