DECLARATION OF BRIAN C. MCCORMACK

I, Brian C. McCormack, declare the following:

1. I am a partner with the law firm of Baker & McKenzie LLP, and I have been with the firm since 1996. I am a patent attorney, and I worked with Postini, Inc. on its patent matters from early 2002 until and through its acquisition by Google Inc. I have personal knowledge of the facts stated in this declaration; I could competently testify to those facts if called upon to do so; and all facts set forth herein are true and correct.

2. In 2002, I became attorney of record in the United States Patent and Trademark Office ("USPTO") for U.S. Application No. 09/675,609. The '609 patent application was assigned on its face from the inventors to "Postini Corporation" according to an assignment document, a true and correct copy of which is attached hereto as Exhibit A.

3. In 2003, our firm filed a utility patent application for U.S. Application No. 10/370,118. The '118 patent application was also assigned on its face from the inventors to "Postini Corporation" according to an assignment document, a true and correct copy of which is attached hereto as Exhibit B.

4. Assignments for the '609 and '118 patent applications were recorded in the USPTO at real/frame numbers 011416/0505 and 014317/0632, respectively. The assignment recordations also listed "Postini Corporation" as the assignee, consistent with the underlying patent assignments. True and correct copies of the recordations are attached hereto as Exhibit C.

5. "Postini Corporation" is an informal reference to the true corporation, "Postini, Inc.," of which the assigning inventors were officers and/or employees. I conducted a LEXIS-NEXIS search on September 24, 2008, thereby confirming that "Postini Corporation" was never a legal entity, at least according to the public records reflected in LEXIS-NEXIS's nationwide database of public records. A true and correct copy of the LEXIS-NEXIS search results that I obtained are attached hereto as Exhibit D. Postini, Inc. was the true company name as evidenced by a true and correct copy of the Certificate of Status evidencing the incorporation of that company on December 13, 1999. This Certificate of Status is attached hereto as Exhibit E.

6. Accordingly, and to show an uninterrupted chain of title from the inventors to the true company, Postini, Inc., this declaration is being recorded as a name change from Postini Corporation to Postini, Inc.

I hereby declare that all statements made herein of my own knowledge are true and that all statements made on information and belief are believed to be true, and further that these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code, and that such willful false statements may jeopardize the validity of the subject patent.
