collect damages for past infringement;

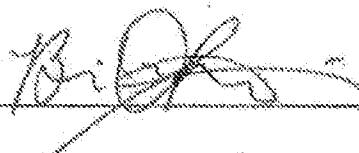

assigned and that I have not executed and will not execute any instrument or assignment in conflict

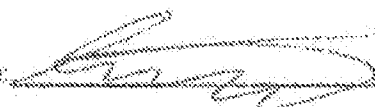

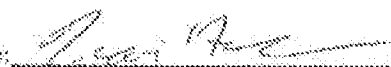

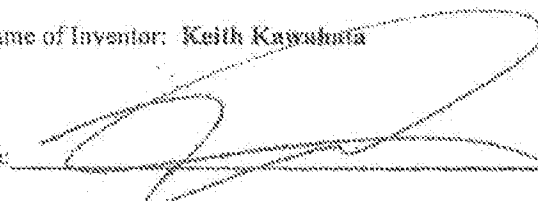
