AND I HEREBY further assign and transfer to Crystal Waves LABs Limited all priority rights derived from such application therefore by virtue of the International Convention for the Protection of Industrial Property for any and all member countries of the aforesaid International

convention and do hereby assign and transfer to Crystal Waves LABs Limited the sole right to file further applications for patents under the patent laws of any country of the world based on any improvements disclosed in said application as fully and entirely as the same would have been held by me had this assignment not been made.

AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith.

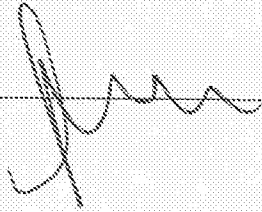
