ASSIGNMENT

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN, be it known that for and in consideration of the sum of One Dollar (\$1.00), and other valuable and legally sufficient considerations, the receipt of which by the said **Assignor** from the said **Assignee** is hereby acknowledged, the said **Assignor** has sold, assigned and transferred, and by these presents do sell, assign and transfer unto the said **Assignee**, and its successors, assigns, and legal representatives, the entire rights, titles and interests for China in and to the inventions and applications herein identified, the priority rights available to them in terms of the Paris Convention, and any Letters Patents of China that may issue for said inventions, together with the entire rights, titles and interests in and to said inventions and applications for Letters Patents, the priority rights available to them in terms of the Paris Convention, and Letters Patents therefor in all countries foreign to China; to have and to hold for the sole and exclusive use and benefit of the said **Assignee**, its successors, assigns and legal representatives, to the full end of the term or terms for which any and all of said Letters Patents for said inventions may issue.

And the said **Assignor** does hereby covenant and agree, for itself and its legal representatives, that it will assist its said **Assignee** in prosecution of the applications herein identified; in the making and prosecution of any other applications for Letters Patents that the said **Assignee** may elect to make



covering the inventions herein identified, as hereinbefore set forth; in vesting in the said **Assignee** like exclusive titles in and to all such other applications and Letters Patents; and in prosecution of any interference which may arise involving said inventions, or any applications or Letters Patents herein contemplated; and that it will execute and deliver to the said **Assignee** any and all additional papers which may be requested by the said **Assignee** to fully carry out the terms of this Assignment.

And the said **Assignor** does hereby covenant with the said **Assignee**, its successors, assigns and legal representatives that the rights and property herein conveyed are free and clear of any adverse assignment, grant, mortgage, license or other encumbrance, and that it has the full right to convey to the same in manner and form as herein expressed.
