## PATENT ASSIGNMENT

WHEREAS, I, Juan José Campderà Lozano, a citizen of the Spain, having a mailing address at C/ Tallinares, 18 – 2º 1ª, Gavá Mar, Barcelona, Spain 08850 (hereinafter referred to as "Assignor"), am the sole inventor of the design for the article of manufacture disclosed and/or claimed in United States Design Application No. 29/598,600 entitled "Weightloss Belt", having a filing date of March 27, 2017 and in United States Design Application No. 29/598,604 entitled "Weightloss Belt", having a filing date of March 27, 2017 (hereinafter referred to as the "Applications"), both of which claim priority to European Community Design Application 003395938-0001 and European Community Design Application 003395938-0002;

NOW, THEREFORE, for One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby sell, assign, transfer and set over unto Assignee, its successors and assigns, the entire right, title and interest in and to the Applications and the invention disclosed and/or claimed therein, and in and to all patents of the United States and in any and all foreign countries which may be issued therefore, and in and to all patent applications, including all continuations, continuations-in-part, divisionals, reexaminations and reissues thereof in the United States and the equivalents thereof in any and all foreign countries, together with all claims for damages by reason of any past, present or future infringement thereof, along with the right to sue for and collect the same, and to obtain all other possible remedies for Assignee's own use and enjoyment as fully and completely as the same would have been held by Assignor had this Assignment and sale not been made. The said entire right, title and interest shall vest irrevocably in Assignee, and this Assignment shall inure to the benefit of Assignee, its successors, assigns and other legal representatives, and shall be binding upon Assignor, and Assignor's successors, assigns, and legal representatives.

Assignor covenants and agrees, upon request by Assignee, without additional compensation, but at no expense to Assignor, to execute or assent to foreign applications, and to execute all papers, assignments or other documents as requested by Assignee, and Assignor covenants to provide testimony by affidavit or otherwise on behalf of Assignee in any proceeding before the United States Patent and Trademark Office ("USPTO"), foreign patent authority, state or federal court, or other decision-making body, and that, in general, Assignor covenants to cooperate fully with Assignee as necessary or desirable to vest the enjoyment of, and to secure, perfect, maintain or enforce said entire right, title and interest in and to said Applications and any patents issuing therefrom or related thereto in and to Assignee. Assignor further covenants that no instrument has been executed that is contrary to this Assignment nor has Assignor taken any action contrary to this Assignment nor will Assignor do so in the future.

Assignor hereby authorizes post-signature entry of the filing date and serial number assigned to the Applications by the USPTO in the spaces provided above in order to ensure proper identification of the Applications being assigned hereby.
