assigns to obtain and enforce proper patent protection for said invention in the United States or any foreign country.

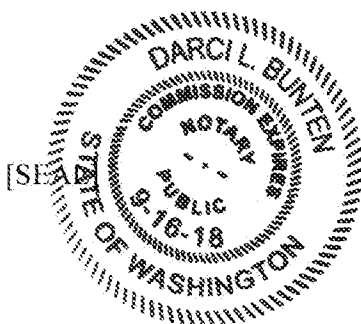

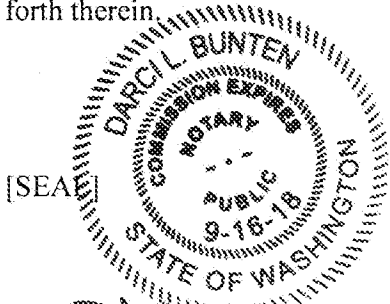

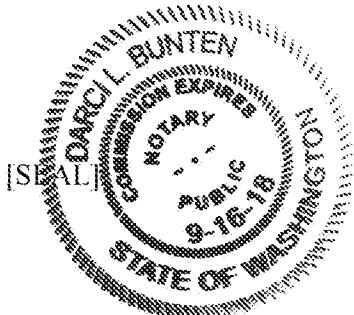
