NOW, THEREFORE, in consideration of One Dollar (\$1.00), the receipt of which is hereby acknowledged, and for other good and valuable consideration, *ASSIGNORS* hereby sell, assign, and transfer to said *ASSIGNEE*, its successors, and its assigns, the entire right, title, and interest—including the right to sue for past infringement, if any, and the (future) right to claim priority—in and to said design application, any and all inventions disclosed in said design application, any and all improvements made to said inventions, any and all applications (including divisions and continuations) anywhere in the world claiming priority to said design application, and any and all patents or registrations that may be granted anywhere in the world on said design application or on any application (including divisions and continuations) claiming priority to said design application, including any and all substitutions, renewals, re-examinations, extensions, and reissues of such patents.

ASSIGNORS hereby authorize and request the Patent Office officials in the United States and its territorial possessions, and in any and all foreign countries, to issue, when granted, any and all Letters Patents on said design application, or on any application claiming priority to said design application, including any and all substitutions, renewals, re-examinations, extensions, and reissues, to said *ASSIGNEE* as the assignee of the entire right, title, and interest in and to the same, for the sole use and behalf of said *ASSIGNEE* and said *ASSIGNEE'S* successors and assigns, to the full end of the term for which said Letters Patents may be granted, as fully and entirely as the same would have been held by *ASSIGNOR(S)* had this sale, assignment, and transfer not been made; and

ASSIGNORS hereby authorize said *ASSIGNEE*, its successors and assigns, to file applications for patent in its own name in foreign countries in connection with the inventions hereby transferred, to claim in such applications the priority of said United States design application under the International Convention or otherwise, and to secure in its own name the patent or patents issued thereon; and

ASSIGNORS hereby agree that, upon request, *ASSIGNORS* will sign all papers, and make all rightful oaths, and do all acts which said *ASSIGNEE*, its successors or assigns, considers necessary in connection with said United States application or with any other United States or foreign application that may be filed in connection with said inventions or any improvements thereon, and in connection with any patents issued or reissued thereon.



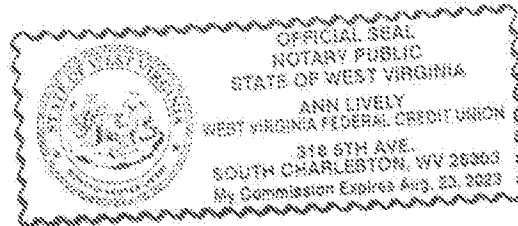

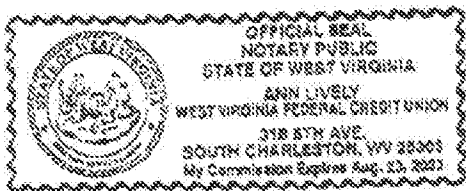
