THIS PATENT RELEASE AND REASSIGNMENT is made as of April 27, 2017, by NXT Capital, LLC (“Grantee”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, TMI International, LLC, a Delaware limited liability company (“Grantor”) and Grantee were parties to that certain Patent Security Agreement dated as of October 21, 2014 (the “Security Agreement”) pursuant to which the Grantor granted a security interest to Grantee in certain Patents (as defined in the Security Agreement) and Patent Collateral (as defined below) as security for certain obligations owing by Grantor to Grantee, including the Patents set forth on Schedule 1 hereto;

WHEREAS, the Security Agreement was recorded by the United States Patent and Trademark Office on October 21, 2014, at Reel 033996, Frame 0791;

WHEREAS, Grantor has requested that Grantee release its security interest in the Patents and Patent Collateral and reassign any and all rights in the same to Grantor.

(i) each Patent and application for Patent listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof; and


(ii) all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future infringement of any Patent.
