NOTICE OF RELEASE OF
SECURITY INTEREST IN PATENTS

This NOTICE OF RELEASE OF SECURITY INTEREST IN PATENTS (this “Release”), effective as of April 26, 2017 is made by Antares Capital LP, in its capacity as Second Lien Agent (referred to herein as the “Agent”) and as successor in interest to General Electric Capital Corporation (“GECC”), in favor of Nielsen & Bainbridge, LLC, a Delaware limited liability company (the “Company”), pursuant to that certain Second Lien Guaranty and Security Agreement, dated as of August 15, 2014 (as such agreement may have been amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the “Guaranty and Security Agreement”), among the Company, the Agent and other parties thereto.

W I T N E S S E T H:

WHEREAS, in connection with the Guaranty and Security Agreement, the Company executed and delivered the Second Lien Patent Security Agreement, dated as of August 15, 2014, which was recorded with the United States Patent and Trademark Office (the “USPTO”) on August 20, 2014, at Reel/Frame No. 033570/0222 (the “Patent Security Agreement” and together with the Guaranty and Security Agreement, the “Security Agreements”);

WHEREAS, pursuant to the Security Agreements, the Company mortgaged, pledged and hypothecated to GECC for the benefit of the Secured Parties, and granted to GECC a Lien on and security interest in all of its right, title and interest in, to and under the Patent Collateral (as defined in the Patent Security Agreement), including, without limitation, those referred to on Schedule A attached hereto;

WHEREAS, pursuant to that certain Assignment of Intellectual Property Security Agreement, dated as of August 21, 2015 between GECC and the Agent (the “Assignment”), GECC assigned to the Agent its Lien on and security interest in all of its right, title and interest in, to and under the Patent Collateral, including, without limitation, those referred to on Schedule A attached hereto;

WHEREAS, the Assignment was recorded with the USPTO on September 23, 2015 at Reel/Frame 036665/0127, in favor of the Agent; and

WHEREAS, the Agent desires to release its Lien on and security interest in the Patent Collateral and has duly authorized the execution, delivery and performance of this Release.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent agrees, for the benefit of the Company, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Security Agreements (it being understood that, in the event of any conflict, such terms shall have the meanings provided or provided by reference in the Guaranty and Security Agreement).

SECTION 2. Release of Security Interest. The Agent does hereby release, relinquish and discharge its Lien on and security interest in, and right of setoff against, the Patent Collateral, and hereby reassigns to the Company, any right, title, or interest it may have in the Patent Collateral.

SECTION 3. Termination. The Agent, without any recourse, representation or warranty, hereby terminates and cancels the Patent Security Agreement.

SECTION 4. Further Assurances. The Agent hereby authorizes the Company or the Company's authorized representative to (i) record this Release with the USPTO, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Agent in the Patent Collateral and/or (iii) otherwise record or file this Release in the applicable governmental office or agency. The Agent further agrees to execute and deliver to the Company any and all further documents and instruments, and do any and all further acts which the Company (or their agents or designees) reasonably request (at the Company's sole cost and expense) in order to confirm this Release and the Company's right, title and interest in, to and under the Patent Collateral.

SECTION 5. Choice of Law. This Release shall be governed by, and construed in accordance with, the laws of the state of New York, but giving effect to federal laws applicable to national banks.

SECTION 6. Counterparts. This Release may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.
